Service & Maintenance Plan Details

The Secure One Service and Maintenance Plan includes the following:

- One visit to your premises at the end of every twelve months in order to carry out preventative maintenance in accordance with the British Standard detailed below.
- The provision of a Secure One security engineer call-out facility 24 hours per day, 7 days per week, 365 days a year, should you ever need it.
- All labour costs for a callout associated with a breakdown of the system. However if parts are required these are chargeable.

Every annual preventative maintenance visit will be carried out in accordance with British Standard 4737 and includes the following:

- Check installation, location and siting of all equipment and devices against specification.
- Check operation of all detection devices.
- Inspect all flexible connections.
- Check mains and stand-by battery power supplies, including charging rates.
- Check control unit for correct operation.
- Check remote signaling equipment physical connections.
- Test remote signaling equipment communications to the Alarm Receiving Centre. (Applicable to monitored alarm systems only).
- Check all audible warning and alarm devices.
- Check system is fully operational.
- Provide an engineer's report.

Terms and Conditions – Main Provisions

- The Secure One Service and Maintenance Plan includes intruder alarm systems within domestic homes only. It does not include security lighting, door entry systems, surveillance systems or remote monitored systems.
- The plan excludes DIY and radio intruder alarm systems.
- The following are chargeable for both labour and parts:- all visits to faults caused by Acts of God; failure of power supply; fire; damage caused by the customer or by the customer's negligence; wilful damage by any person, animal or creature.
- You can cancel your maintenance contract at any time with no questions asked. A refund will be given (if there are no other amounts due to us) for any unexpired period already paid for, less an administration charge equivalent to one month's cover.

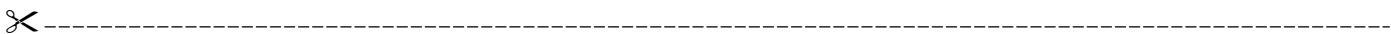
